### AdvancED

#### Mission

 Lead and empower the education community to ensure that all learners realize their full potential.

#### Governance

 AdvancED is governed by an independent Board of Trustees and relies on a dedicated staff. Most critical to its success are the more than 18,000 volunteers—including educators, researchers, policy analysts, business leaders, and others—who've chosen to donate their time and expertise to help conduct external reviews, analyze the data, and provide guidance to schools.

### **System Accreditation**

#### An international protocol for institutions committed to systemic, systematic and sustainable improvement

- Builds capacity of the system and its schools to increase and sustain student learning
- Stimulates and improves effectiveness and efficiency throughout the system

# Value of System Accreditation

- Becomes a member of the world's largest educational community
- Provides a framework for the processes of schooling and building capacity throughout the district that is systemic, systematic, and sustainable.
- Gives an independent third party look for community/public to see validation of the system's work and/or areas for imporvement
- Sets Standards for Quality at school and district levels
- Age-old method for colleges and universities to know students come from quality schools
- Reciprocity of credit transfer from one school to another
- Accredited schools may offer AP courses from College Board and serve as a testing center for SAT
- Provides a stamp of approval in ensuring quality, particularly important with today's mobility of students
  - Upholds the public trust

## **AdvancED Standards for Quality and Indicators**

Standards are research-based, comprehensive quality statements that describe conditions and factors that contribute to a quality educational experience and operational effectiveness.

AdvancED research confirms the belief that every system/school requires:

- stable governance, management, and leadership;
- a coherent course of study;
- a reliable system by which to assess students' progress;
- instructors who have a clear understanding of what they aim to teach, how, and why; and
- access to the resources they need.

The AdvancED Standards for Quality provide direction for every institution.

#### **External Process:**


- Assignment of Lead Evaluator and Composition of External ReviewTeam Members
- External Review Process (interviews, observations, and review of evidence documentation)
- Team Findings (Standards/Indicators ratings, *eleot* scores, student performance data and stakeholder findings, Index of Quality scores)
- Exit Report (Board meeting to share accreditation findings and recommendation)
- Final report to City of Cape Coral Municipal Charter School system in approximately 30 days

## Index of Education Quality<sup>™</sup> (IEQ<sup>™</sup>)

- AdvancED Accreditation is not about earning a label for a one-time evaluation. Rather, it recognizes and supports the journey of continuous improvement. The Index of Education Quality™ (IEQ™) is a formative measure for placement on a continuum of performance, pinpointing areas of success as well as areas in need of support and/or focus.
- The Index of Education Quality provides a holistic measure of overall performance. By basing the score on data aggregated from each AdvancED Standard and diagnostic results from student, parent and staff/teacher surveys, the IEQ framework recognizes and supports the whole continuous improvement journey. Each institution's IEQ provides a benchmark to assess and guide future decisions.

By analyzing the components of an IEQ score, an institution can focus its attention and actions on activities and systems that optimize learning for all students. 13
